Mondi Neusiedler GmbH (Theresienthalstraße 50, A-3363 Ulmerfeld-Hausmening) is asked to supply Antalis bv (Wittevrouwen 15, 1358 CD Almere, The Netherlands) with the paper grade **"Nautilus® Classic"** and **"Nautilus® SuperWhite"**.

The paper grades mentioned above fulfils the requirements of the German Recommendation XXXVI (BfR) for secondary packaging applications, the direct contact with foodstuffs which are peeled, shelled or washed prior consumption and the direct contact with dry foodstuffs such fatty foodstuffs, which are in accordance with Annex III Table 2 of Commission Regulation (EU) Nr. 10/2011 with a minimum correction factor 2.

In accordance with Annex III; Table 2 of Commission Regulation (EU) Nr. 10/2011 with a minimum correction factor 2 are the following examples:

- Pastry, biscuits, cakes, bread, and other bakers' wares, dry: With fatty substances on the surface (RN: 02.05)
- Pastry, cakes, bread, dough and other bakers' wares, fresh: With fatty substances on the surface (RN: 02.06)
- Chocolate, chocolate-coated products, substitutes and products coated with substitutes (RN: 03.01)
- Confectionery products: In solid form: With fatty substances on the surface (RN: 03.02 A)

The production process is certified according EN 15593 and fulfils the requirements of the Reg (EC) 2023/2006 for folio formats and reels.

Thus, the paper grades is in compliance with the rules of Reg(EC) 1935/2004 and may be used safely for food packaging for the applications mentioned.

This statement is valid for one year from the date of issue or good till cancelled.
